ORDINANCE NO. 2025-06

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARLAN, IOWA, BY AMENDING PROVISIONS PERTAINING TO SNOW EMERGENCY VIOLATIONS.

BE IT ENACTED by the City Council of the City of Harlan, Iowa:

SECTION 1. SECTION MODIFIED. Section 69.12 of the Code of Ordinances of the City of Harlan, Iowa, is repealed and the following adopted in lieu thereof:

69.12 SNOW REMOVAL.

- 1. The Street Superintendent and City Administrator shall formulate a snow and ice control program which shall be adopted by resolution of the Council.
- 2. In the event of a snow emergency, as set out in the snow and ice control program, no person shall park, abandon, or leave unattended any vehicle on any public street, alley, or City-owned off-street parking area during any snow emergency unless the snow has been removed or plowed from said street, alley, or parking area and the snow has ceased to fall. During such emergency, parking is specifically prohibited on north-south streets between the hours of 8:00 a.m. and noon, and on east-west streets between the hours of 1:00 p.m. and 5:00 p.m. unless the cleaning operations have been completed.
- 3. A violation of this section will be a fine as provided in Section 70.03 and result in the immediate towing of the vehicle.

SECTION 2. SECTION MODIFIED. Section 70.03 of the Code of Ordinances of the City of Harlan, Iowa, is repealed and the following adopted in lieu thereof:

70.03 PARKING VIOLATIONS: ALTERNATE. Uncontested violations of parking restrictions imposed by this Code may be charged upon a simple notice of a fine payable at the office of the City Clerk. The simple notice of a fine shall be in the amount of \$50.00 for snow route parking violations and \$10.00 for all other violations except improper use of a persons with disabilities parking permit. If such fine is not paid within 30 days, it shall be increased by \$5.00. The simple notice of a fine for improper use of a persons with disabilities parking permit is \$100.00. Failure to pay the simple notice of a fine shall be grounds for the filing of a complaint in District Court.

(Code of Iowa, Sec. 321.236[1b] and 321L.4[2])

SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, 4approval, and publication as provided by law.

RESOLUTION NO. 2623

RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR GRANDMA B'S DREAM PLAYGROUND

WHEREAS, the City of Harlan, Iowa, has heretofore entered into a contract with Patriot's Choice Contracting of Harlan, Iowa, for the Grandma B's Dream Playground project; and

WHEREAS, during the course of construction, it was determined that the concrete mix originally specified at 4,000 PSI should be upgraded to an M4 mix to better support the anticipated equipment loads and long-term durability of the playground surface; and

WHEREAS, the M4 concrete mix provides enhanced strength, improved durability, and greater resistance to cracking and surface wear, ensuring a longer service life and reduced maintenance needs; and

WHEREAS, the upgraded mix will also allow contractors to safely maneuver construction equipment such as skid loaders around the site without compromising the integrity of the concrete; and

WHEREAS, the proposed change order increases the overall project cost by a maximum of \$8,667.45 to accommodate the higher-grade concrete mix;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HARLAN, IOWA:

Section 1. That the contract with Patriot's Choice Contracting of Harlan, Iowa, be amended as outlined in Change Order No. 1, upgrading the concrete mix from 4,000 PSI to M4.

Section 2. That the total contract price is hereby increased by a maximum of \$8,667.45 as specified in Change Order No. 1.

Section 3. The Mayor is hereby authorized to sign Change Order No. 1 on behalf of the City of Harlan.

Section 4. Change Order No. 1 is hereby accepted and approved by the City Council of the City of Harlan, Iowa.
